5. Sources of income and utilization of funds

All the income of the society shall be utilized only for the promotion and upliftment of the Aims and object of the society and sources of income of the society are as under:

- Admission Fee and Subscription from the members of the society.
- Donation, Contribution and / or grants from private, public, governments departments or institution or any other suitable source from India or abroad.
- Contribution from Honorary member and patrons.
- Income from gifts, legacies of movable or immovable properties, and
- Income from other activities of the society including publication.

6. Financial Year

The first financial year of the society shall end on 31st of March, 2015 and the next financial Year of society shall start from 1st April to 31st march of next Year.

7. Audit of Accounts

The accounts of society shall be compulsorily audited by the auditor (Chartered Accountant) every year. Once appointed chartered Accountant can only be removed either by his resignation or by way resolution passed in the meeting of general body with 3/4th majority.

8. Operation of the Bank Account

Bank Account of the society shall be operated by President and or any other person authorized by them in writing.

9. Annual list of Governing Body to be filed

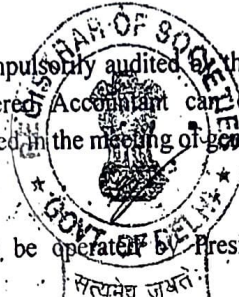
Once in every year a list of the office-Bearers and the executive Members (of the Governing Body) shall be filed in the office of the Register of societies, Delhi as it is required under section 4 of the societies Registration Act, 1860.

10. Legal proceedings (Sec 6 of the Act)

The society may sue or be sued in the name of the President/Secretary as per the provisions laid down under Section 6 of the Societies registration Act, 1860

11. Amendment

Any amendment in memorandum Rules and Regulation Will carried out in accordance with section 12 and 12 A of the Societies Registration Act, 1860.



12. Dissolution and Adjustment of Affairs

If the society needs to be dissolved, it shall be dissolved as per provisions laid down under the section 13 and 14 of the societies Regulation Act, 1860, as applicable to Union Territory of Delhi shall apply to this Society.

13. Application of the Act

All the provision under all the section of the "Societies Registration Act, 1860" as applicable to the Union Territory of Delhi shall be apply to this society.
